2024 HIGHLIGHTS

Open House

June 2024 marked the one-year anniversary of JCPH's move to our new location in Lee's Summit. To celebrate this milestone, the department hosted an open house for local officials, community partners, and fellow University Health staff.

More than 70 guests toured the facility, many experiencing the state-of-the-art infrastructure for the first time, and learned about the pivotal public health programs and resources JCPH offers. The new location has significantly expanded the department's reach, serving nearly 51,000 people in its first year—an impressive increase from the 48,945 served in the final year at the former Independence location.

University Health President and CEO Charlie Shields delivered opening remarks, and the event culminated with a commemorative plaque presented by Jackson County Executive Frank White Jr. and Legislature Chairwoman Jeanie Lauer. As JCPH prepares to celebrate a century of service in 2025, both reaffirmed their support for public health and prevention initiatives in Jackson County.

In 2024, our dedicated staff showed off their public health pride while taking our Mobile Service Unit to the streets, schools, libraries, churches—and beyond—of Eastern Jackson County. Each event was a valuable opportunity to exchange public health knowledge and connect new community members to the resources they needed, from food assistance to vaccinations to harm reduction.

Community Engagement & Policy

Building Momentum: InCoLab's Progress

In 2024, Jackson County Public Health continued to provide backbone support for InCoLab, the coalition leading Eastern Jackson County's Community Health Improvement Process (CHIP). The group is a collaboration among JCPH, community partners, and residents, representing over 100 local organizations and communities working to advance impactful health initiatives. JCPH ensures the ongoing success of the collective impact initiative by promoting cross-sector communication, alignment, and key operational functions.

In 2023, Eastern Jackson County residents and organizational leaders gathered for the inaugural Community Health Summit. At this event, two Community Health Innovation Labs were launched to tackle the region's most pressing challenges:

- Poor mental and behavioral health outcomes
- Housing and economic instability

This year alone, Lab members, Innovators Network leaders, and Summit attendees have contributed over 800 hours to advancing health equity and transformational change in the area. That's equivalent to 33.9 days of dedicated collaborative work!

Improving Tenant Health

In May, JCPH released a policy brief on Proactive Rental Inspections, highlighting the housing challenges faced by tenants in Eastern Jackson County.

A proactive rental inspection program helps to ensure that renters have safe and healthy living environments. Research shows that tenants are more likely to encounter inadequate living conditions compared to homeowners, making such programs critical to public health.

Currently, only four cities in EJC have proactive rental inspection programs in place: Buckner, Grandview, Raytown, and Sugar Creek.

Expanding these initiatives across the region could significantly improve housing safety and foster healthier communities for everyone.

Celebrating Community Health Workers

At JCPH, our Community Health Workers (CHWs) are the backbone of many vital programs and initiatives. Their dedication to fostering health equity and supporting our residents has made a tangible impact throughout the year.

Our CHWs organized and participated in over 73 community events, reaching thousands of residents. These events ranged from hosting monthly mobile food pantries, to providing education at health fairs, to tabling at farmers markets where they connected individuals with resources.

Beyond the numbers, our CHWs have built trust within the communities they serve. Their ability to meet residents where they are—physically and emotionally—has strengthened relationships and fostered a deeper sense of connection. Through their work, they bridge the gap between public health resources and the people who need them most.



In response to the ongoing opioid epidemic, in 2024 JCPH partnered with the Raytown Fire Protection District to install free Narcan dispensers at all three Raytown Fire Stations. These 24/7 dispensers provide residents with Narcan nasal spray, fentanyl test strips, and educational materials, empowering the community to respond effectively to opioid overdoses.

"I am profoundly thankful for the partnership," says Matthew Cushman, Community Paramedic with the Raytown Fire Protection District. "We have seen significant reductions in death associated with free and accessible Narcan... this continues to make sure that in the neighborhoods we serve, there is opportunity to save lives..."

The dispensers address a critical need, as synthetic opioids like fentanyl continue to threaten

> public health. Since 2017, over 200 lives have been lost to opioid overdoses in Eastern Jackson County. While 2023 saw a decline in fatal overdoses, JCPH remains committed to expanding access to lifesaving tools and education, ensuring no resident faces barriers to help in a crisis.



DIVISION ACCOMPLISHMENTS

Health Services

Our Health Services division is committed to providing EJC families with accessible, high-quality clinical services. Using innovative outreach and community-driven initiatives, we work to meet people where they are and reduce barriers to care.

Bringing Care to the Community

In 2024, our team strengthened partnerships to bring health services directly into the community. Clinics based in libraries, churches, and schools have served as trusted, convenient access points for essential care, including immunizations. These initiatives have been instrumental in reaching underserved populations and fostering connections in familiar, community-centered environments.

Culturally Competent Care for All

Understanding that effective care goes beyond clinical services, the Health Services team prioritizes cultural navigation. Our staff works closely with visitors to bridge gaps in language, culture, and trust, ensuring everyone has the tools they need to make informed decisions about their health.

In one instance, a family who had just immigrated from Cuba walked into our clinic. The pregnant mother and her two young children were adjusting to a new environment, a new language, and the absence of their father, who was still overseas.

When our Cultural Navigator learned their story, she helped translate all of their records and organized the necessary information for starting school. Over the next several months, the children thrived in school, the mother welcomed her new baby, and the father reunited with his family in the U.S. Through it all, our team helped this family connect to local resources and navigate their new life changes.

This family is one of many who found support at JCPH last year. In 2024, we proudly served thousands of Eastern Jackson County residents and averaged 321 staff interpretations each month, ensuring good health remains within reach for everyone who walks through our doors.

Epidemiology & Data Analytics

Outbreak Preparedness in Action

In 2024, our region faced outbreaks of measles, whooping cough, and chickenpox. Missouri also saw its first case of bird flu (H5N1) in humans. Each incident underscored the importance of preparedness and the necessity of having predeveloped response plans, demonstrating how swift, informed action can mitigate the impact of communicable diseases.

Disease Containment Toolkits

The Epidemiology and Data Analytics division prioritized readiness for everyday outbreaks by developing comprehensive plans for swift response to the ten highest-risk diseases affecting our community.

These "Disease Containment Toolkit Packages" are designed to equip our team and partners with the tools needed to identify, investigate, and control the spread of communicable diseases.

To bolster public health response capabilities, we finalized toolkits for the following diseases this year:

- Salmonellosis
- Campylobacteriosis
- · Diphtheria
- Hepatitis A
- Measles
- Mumps
- Norovirus
- Pertussis (Bordetella)

- Shigellosis
- Cyclosporiasis
- H5N1 (Bird Flu)
- Tuberculosis (TB)
- Latent Tuberculosis Infection (LTBI)
- General Gastrointestinal Outbreaks

Each toolkit provides step-by-step guidance for outbreak containment, from case investigation and contact tracing to public communication and prevention strategies.

Why It Matters

Preparedness saves lives. These toolkits not only enhance our ability to respond to outbreaks efficiently, but also strengthen trust with the community by ensuring transparency and readiness. With these resources, the division is better equipped to protect the health of our residents, prevent outbreaks, and reduce the burden on healthcare systems.

RESPIRATORY ILLNESS DASHBOARD

Curious about how respiratory illnesses are affecting our community this season? In 2024, the Data Analytics Team developed the Respiratory Illness Dashboard—a comprehensive tool that provides timely insights into the impact of illnesses such as influenza, COVID-19, and other respiratory infections in Eastern Jackson County.

- Make informed decisions about community health strategies.


This initiative represents a significant step toward greater transparency and public engagement, ensuring that everyone in our community can stay informed and prepared throughout respiratory illness seasons.

Emergency Preparedness

Our Emergency Preparedness division collaborates with local agencies and first responders to strengthen our community's ability to respond to public health crises.

In October, Jackson County Public Health hosted a drive-thru vaccination clinic at Grandview High School, coordinated by the Emergency Preparedness team. This weekend event provided a convenient and free opportunity for community members to receive flu and COVID-19 vaccines while also serving as an emergency preparedness drill, training our staff in how to distribute resources en masse during a crisis.

This year we accepted walk-ins in addition to appointments, expanding our impact. More than once, our team saw passing drivers pull u-turns so they could come and get vaccinated.

During the clinic, JCPH administered 318 doses of flu and COVID-19 vaccines to 199 people. Additionally, our team distributed 108 overdose prevention kits, which included Narcan and fentanyl test strips.

Beyond delivering essential services, the clinic offered valuable hands-on training for staff and tested emergency response protocols, reinforcing our readiness for large-scale emergencies.











STRENGTHENING PREPAREDNESS WITH THE POINT OF DISPENSING PROGRAM

In 2024, our Emergency
Preparedness Team revitalized its
Point of Dispensing (POD) program,
working closely with community
partners to enhance Jackson
County's ability to distribute
lifesaving medications, like antibiotics or vaccines, during disease
outbreaks or bioterrorism events.
This critical program evaluates

and secures sites like schools, community centers, long-term care facilities, libraries, and faithbased organizations as potential emergency dispensing locations.

A dozen organizations in Eastern Jackson County committed to working with JCPH to make their facilities accessible for emergency dispensing. These organizations represent 20+ locations, which include indoor ADA accommodations and parking lots for minimal contact drivethru dispensing. Their variety of sizes, locations, and audiences will ensure Jackson County is prepared for a broad range of threats to our population's health.

Operations

Improved Grant Management System


In 2024, we expanded our grant management system to include a comprehensive approval process for new grants. Using a guided form, any team member can now propose a grant-based project to address community needs. These proposals are then automatically moved through a multi-stage review process to ensure alignment with our mission and identify measurable outcomes. This process enhances efficiency and fiscal accountability while empowering staff to identify additional funding sources to support their work.


Enhanced Insurance Billing Process

We also expanded our insurance billing capabilities by implementing a process to analyze billing reports from our third-party billing provider. This analysis identifies which insurances cover vaccines, which vaccines are covered, average payments received, and payment time lags. With this information, we can forecast profits, recognize trends, and address areas needing improvement. This initiative not only supports accurate financial forecasting but also bolsters our overall fiscal responsibility.






2024 FISCAL YEAR TOTAL REVENUE \$6,193,136.15




















2024 FISCAL YEAR TOTAL EXPENDITURES \$6,765,890.55











Communications

The Communications division plays a vital role in connecting residents with the information they need to make informed decisions about their health.

Timely, Targeted, and Inclusive Messaging

In 2024, we provided parents and school districts with critical updates on topics like vaccine requirements, local disease outbreaks, and lead testing in school water systems, promoting the safety and well-being of children across the county.

To better serve our diverse population, we created Spanishlanguage materials for all public-facing services. Additionally, we strengthened our email marketing efforts, delivering timely and targeted messages to keep the community informed about health programs, events, and resources. These initiatives reflect our ongoing commitment to clear, inclusive, and impactful communication in public health.

Welcoming a New Look

We serve lots of families at JCPH — and now our building reflects that! This year, our team designed bright, welcoming wall art for our once-empty lobby, waiting room, clinic, and hallways, plus bilingual signage to make it easier for everyone to navigate. We hope this colorful change will help clients of all ages feel more relaxed during their visit.

Strategic Initiatives

The Strategic Initiatives division plays a key role in staff development and quality improvement, ensuring JCPH's work aligns with the needs of our community. The team also helps develop the next generation of public health workers by coordinating our internship program.

Supporting the Next Generation of Public Health

Launched in 2023, JCPH's internship program provides students with hands-on experience in the world of public health. Over the past year, our staff hosted and mentored 12 interns pursuing degrees in public health, social work, epidemiology, and more.

Our interns contributed to a wide range of impactful projects, including:

- Assisting with data collection and analysis for the Community Health Improvement Plan (CHIP).
- Supporting the Maternal and Child Health program by researching effective community engagement strategies.
- Developing content for public health campaigns focused on overdose education and teen pregnancy prevention.
- Enhancing data analytics capabilities for tracking communicable disease trends.
- Contributing to research on social determinants of health to inform equitable policy decisions.
- Assisting with the development of the EJC Health Inequities
 Training Program to educate staff on the different health
 challenges faced by each community we serve.

As the public health sector faces a shortage of workers, JCPH is proud of our program's role in fostering the next generation of public health professionals. We look forward to building on its successes in the coming year.



In July 2024, the Strategic Initiatives team led the department's next steps towards accreditation. JCPH submitted all required documentation to the Public Health Accreditation Board (PHAB), advancing our commitment to excellence.

Public health accreditation ensures JCPH is held accountable for providing high-quality essential and foundational public health services to all residents of Eastern Jackson County. Grounded in health equity, accreditation enhances JCPH's organizational structure and capabilities in several key areas, including:

- Data analysis
- Disease prevention
- Emergency preparedness
- Communication, collaboration with community partners
- Connecting residents to health care and social services

Accreditation is a significant accomplishment that only eight health departments in Missouri have achieved.

For over two years, the Accreditation Workgroup has been collecting and finalizing all 210 examples of documentation needed. It's a project that has touched every facet of the department.

In 2025, we hope to celebrate our centennial with the PHAB seal of approval behind our name.
